CCISD FFA LIVESTOCK SHOW AUCTION RULES

1. Agriscience teachers and their appointed show officials will conduct the CCISD FFA Livestock Show and Auction.
2. The number of and types of sales items will be determined by the agriscience teachers upon final check-in of all entries.
3. The following will be the Champion and the Reserve Champion sale order for 2024:

4. Non-animal Divisions must have a minimum of Five (5) entries to qualify for auction
5. All animals making the live auction must sell.
6. All Grand and Reserve Animals and Best of Show Projects must sell
 - A student may only auction one livestock project unless he/she earns Grand or Reserve with two or more different species.
 - A student may auction one livestock project and Best of Show(s).
 - In the event a student places Grand/Reserve in more than one livestock division, the student will be allowed to auction all Grand/Reserve livestock and the Best of Shows.
7. Animals become property of the buyer when the auctioneer indicates that the sale is final.
8. Students are not allowed to make personal contact with buyers after the sale regarding purchasing or having the animal donated back to them. Any student who violates this policy will forfeit all proceeds of the sale.
9. During show week, no pen decorations or other signs will be allowed.
10. Ten percent (10%) of sale price will be withheld on all sales (Auction, Add-on Donations, Premium Donations, etc.) that have been presented and shown on the fair grounds to pay for show expenses.

10. Students whose projects do not sell will have the following options:

- Retain ownership of the animal and select which CCISD approved processor will process the animal. If a student chooses this option, he/she must fill out an animal disposition form.
- Floor the animal and receive market price

11. **Mandatory Thank you letter writing will be held at each campus in February.**

- Students will be given payout summaries, buyer check off sheets, and buyer's plaque for delivery upon completion of writing all thank you notes.
- Before student payouts are processed, students must have their "Thank You" letter approved by an Agriscience teacher and proof of delivery of sale picture on file with the Agriscience teacher
- Deadline to deliver and return signed buyer checkoff sheets:
 - **March 8th, 2024**

ANIMAL PRICING

The pricing of a Supervised Agricultural Experience is separated into two costs. The initial cost of the animal in addition to the cost of housing the animal at the barn facilities. 

CCISD FFA ANIMAL SELECTION PROCESS

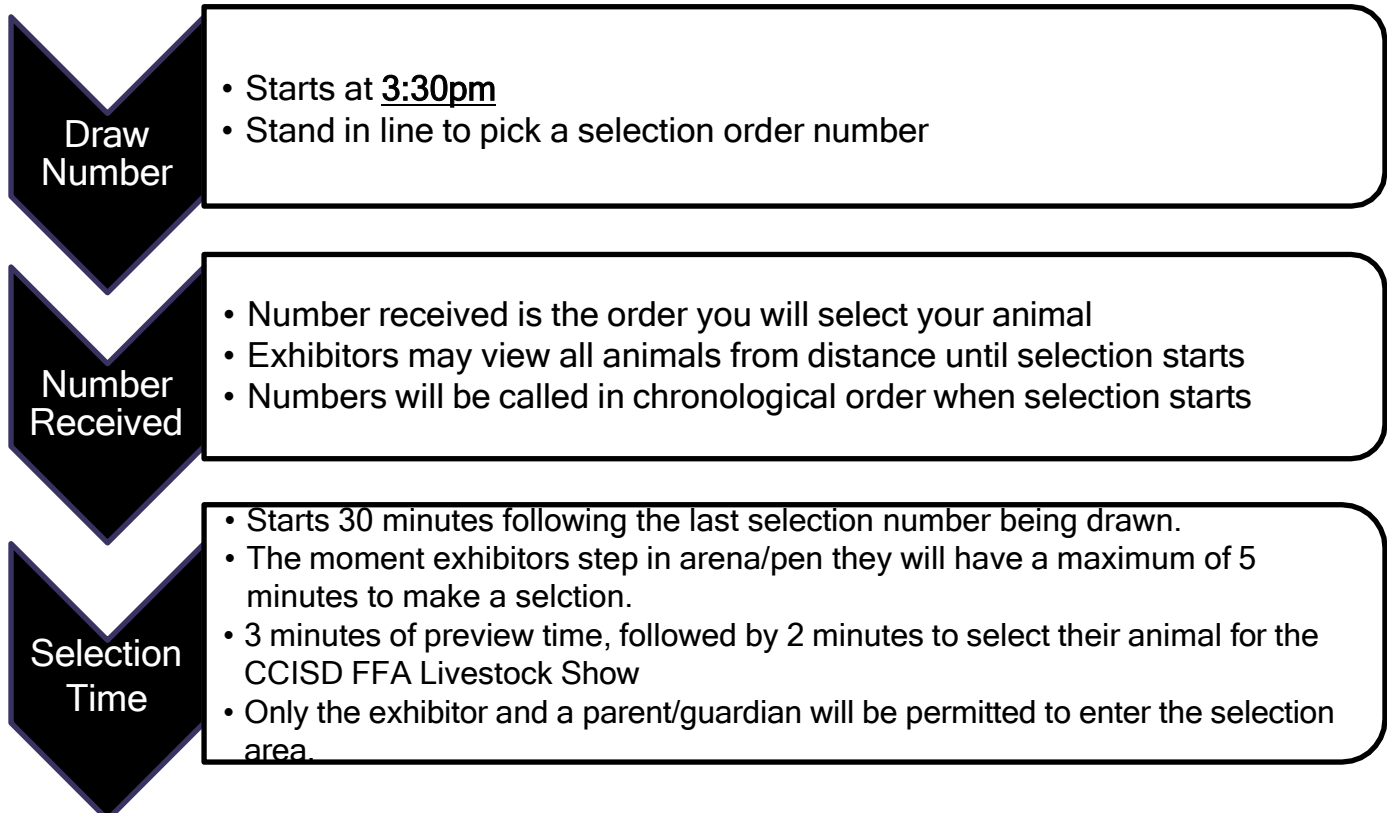

Kemah, TX 77565. Students will draw their selection order number at random beginning at 3:30pm. The selection process will start 30 minutes following the last selection number being drawn.

- All animals will be selected from a central order except for the market rabbits.
- All rabbits will be validated through tattooing at their home campus no later than 11:00AM December 20th, 2023.

CCISD FFA LIVESTOCK SHOW RULES

General Rules

1. The Agriscience teachers of Clear Creek Independent School District and the appointed show officials under their direction, reserve the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard and hereto otherwise arising out of, connected with, or incidental to this educational event. This governing body is later referred to in this instrument as the "Management".
2. The show Management reserves the right to amend and/or add to these rules and regulations as it, in its judgment, may deem advisable. Management authority and responsibility are limited to those activities and events directly related to and being part of the CCISD FFA Livestock Show and Auction Schedule and Rules.
3. The Clear Creek Independent School District, its employees, and appointed show officials will not be liable for any damage(s) resulting from fire, theft, accident, injury or any other adverse situation(s).
4. The Clear Creek Independent School District, its employees, and appointed show officials will be held harmless in the event the CCISD Livestock Show is cancelled for reasons beyond our control.
5. The Agriscience teachers will strictly regulate all construction building or site modification and/or introduction or use of equipment. Prior CCISD administrative approval is required. The Agriscience teachers will make appropriate pen assignments for animals brought into the West Agricultural Facility for the week of the Livestock Show and Auction. Animals housed at the West Agricultural Facility may be reassigned temporarily during the show. Assignments will be determined by Agriscience teachers. Failure to stall in assigned pens will result in a \$50.00 fine, and possible disqualification from the livestock show if not remedied immediately after notification.
6. The show facilities will be closed at 9:00 PM or when the last show is completed for the evening, whichever comes last. The show facility will reopen at 5:00 AM on all show days. On the day following the Auction, the barn will not officially be open to the public until 1:00 PM. If students have an animal that needs to be fed on that morning, it is the responsibility of the student to leave out the right amount of food that needs to be fed to the animal so that the show management team can feed.

7. All alcoholic beverages and tobacco products are barred from the show grounds as per state statutes and local CCISD rules and regulations. Any person caught with an alcoholic beverage or tobacco product will be removed from the show grounds. If that person has an animal project to show, he/she will be barred from further competition and will be reported to proper authorities for disciplinary action.
8. Protests: All protests must be made in writing and submitted to a committee that consist of the Agriscience teachers, the Show Chairman and the CCISD CTE Administration by 12:00 PM January 16, 2024 along with a \$250.00 cash fee, which will be forfeited if the protest is not sustained.
9. Prepackaged foods and soft drinks will be offered for sale by CCISD FFA Booster Clubs, utilizing the provided concession area.
10. Inappropriate behavior, gestures or offensive language will not be tolerated. District code of conduct will be enforced. Consequences will vary depending on severity.

Student Rules & Responsibility

11. Exhibitors must be enrolled in at least one semester of an Agriscience course in the Clear Creek Independent School District during the 2023-2024 school year. Exhibitors must also be paid FFA members in good standing and have satisfactory class attendance records.
12. A student will be eligible to participate for only four years, as defined by school district policy.
13. Exhibitors must abide by all rules in accordance with local district policy regarding eligibility for participation.
14. Students failing to maintain academic eligibility for the CCISD Livestock Show, must remove their CCISD Livestock Show Project from CCISD Facilities by January 10th, 2024.
15. Entry forms, fees, and W-9's for Ag. Mechanics, Breeding Heifers, and Rabbits must be submitted by November 10, 2023. All entries are submitted to the respective Agriscience teachers.
16. Each exhibitor must own his/her animal at the beginning of and throughout the feeding period and must feed, care for, and exhibit his/her own animal. Any break in the ownership or enrollment in CCISD Agriscience program forfeits animal and or exhibitor entries. Exhibitors may only exhibit the designated livestock project officially tagged in their name on the designated selection day.

17. Each exhibitor will feed and care for his/her animal during the entire length of the show.
18. In case an exhibitor is unable to check in his/her project, with prior notification, the project may be checked in by another FFA student, Agriscience teacher, or parent. Projects may only be checked in during designated times. There will not be early or late check- ins.
19. Substitution exhibitors will be approved by the Agriscience teachers.
20. Exhibitors will not be allowed to stay overnight on the show grounds.
21. Hats or caps on exhibitors will not be allowed in the show ring.
22. All students who have assigned facilities and/or used facilities at the FFA project barn before and during the auction, must leave the facility clean, in a sound state of repair.
23. Students failing to sign in and participate in show clean up as designated by their Agriscience teachers (please see schedule) or final assigned facility barn clean up will be fined a \$100.00 fee for each session. All stalls and pens at the barn must be cleaned by the Friday following conclusion of show. This fine will be deducted from the sale of the livestock project or assessed at the conclusion of the show.
24. All fees, if any, owed to the CCISD FFA Livestock Show and Auction must be paid in full. Students will be checked out officially by their Agriscience teacher(s) and respective chairmen. Fees will need to be cleared by March 8, 2024.
25. Exhibitor must be present at time of show.
26. Entry Fee is \$20.00 for animal the following categories: Steers, Lambs, Swine, Goats, Broilers, Turkeys, Rabbits, and Heifers. *Note: These fees are used to help finance show expense.
27. Entry Fee is \$10.00 for the following categories: Ag Mechanics, Floral, Visual Arts and Food Science. *Note: These fees are used to help finance show expenses.

Animal Selection/Identification Rules

28. All steers, lambs, swine, goats, and poultry will be “centrally ordered” through the Agriscience teachers. Students will draw for pick out of a group of like steers, lambs, swine, and goats. All animals must come from this “central order” to be eligible for competition at the CCISD FFA Livestock Show and Auction. The central producer/breeder will be selected by the Agriscience teachers.
 - a. CCISD will provide a 50% refund to an exhibitor, in the event an animal dies with in the first 48 hours of selection.

29. Each student may only purchase, tag-in, and show one animal project in each livestock division. However, for Non-Animal Projects, a student may enter in each class within the division (i.e. one wood project and one metal project.)
30. All livestock and poultry entered in the CCISD FFA Livestock Show Auction will be tagged/banded/tattooed when exhibitors select animals under the supervision of the Agriscience teachers.
 - a. If the animal is not tagged/banded/tattooed on the set date, then the student will not be allowed to exhibit the animal at the CCISD FFA Livestock Show and Auction.
 - b. If an animal loses their official CCISD tag/band(s), the exhibitor must immediately notify their Agriscience teacher so that the animal can be re-tagged/re-banded.
 - c. No non-tagged/non-banded/non-tattooed animal will be allowed to check-in or weigh-in at the CCISD FFA Livestock Show and Auction.
 - d. The tag/band must remain in place until the show and auction is over and the animals have been officially checked-out by official show representatives.
 - e. CCISD animals are not eligible to be tagged or validated for additional shows

Division Rules of Livestock Show

31. Show entries will be limited to the divisions offered.
32. Agriscience teachers are to determine when the judging of classes shall begin.
33. Agriscience teachers will inform the ring steward when students are to enter the arena.
34. All judges' decisions are final.
35. The CCISD Livestock Show and Auction reserves the right to collect a urine sample for laboratorial analysis on all species of Grand Champion and Reserve Grand Champion animals exhibited at the show, and a random draw from each species at show management's discretion. It is the exhibitor's/parents' responsibility to remain with the animal and assist in the collection. Each exhibitor or parent must sign a form indicating that they witnessed the collection of the urine sample. An exhibitor of an animal producing an analysis with a quantity of diuretic, any unapproved medication, or any substance not approved by the FDA will forfeit sales proceeds and will be barred from participation in future CCISD Livestock Show and Auction competitions. All tests will be final without recourse against CCISD Livestock Show and Auction or any of its officers. Upon receipt of test results, checks will be issued to eligible exhibitors.

36. Evidence of the following will result in automatic disqualification from the current year's CCISD Livestock Show and Auction, which includes any sale opportunities. If you have a commitment, it will be voided. Also, any student who violates this policy will forfeit all privileges of being able to show at the CCISD Livestock Show & Auction for the duration of their high school years.
37. Animal abuse: this will be determined by an Agriscience teacher and/or veterinarian.
- b. Physical alteration of the natural conformation of the animal being shown other than castration, dehorning and redocking.
 - i. To include the use of stomach pumps
 - c. Changing out animal; the animal validated for the CCISD Livestock Show and Auction, must be the animal shown and auctioned. Animals will be verified by the following methods:
 - i. Hair will be pulled at selection and kept for validation on the following species: cattle, swine, lambs, and goats.
 - ii. Rabbits will be validated through tattoo no later than December 20th, 2023, tattoo numbers will be recorded.
 - iii. Poultry wing bands will be recorded on date of delivery.
38. All CCISD market animals that are not eligible for the CCISD Livestock Show and Auction must be removed from CCISD property by 9:30 PM on Wednesday, January 10, 2024. All ineligible animals still in the barn after this time will be hauled to local livestock market and sold at market price.
39. The weight of the animal, as certified by the show management team, at the weigh-in time of the show is considered the official weight for the auction sale and the animal will only be weighed once.
40. Official weigh in will be conducted by a weigh in committee.
41. All ear tags must remain in the animal's ears after they are shown. These tags are used for identification purposes. If your ear tag is missing for load out, you will be fined \$100.00.
42. All entered livestock must remain within the fenced show facilities until officially released. If the rule is violated, the exhibitor forfeits the opportunity to show at the CCISD Livestock Show and Auction the following school year, and forfeits all of their proceeds from the sale.

42. There will be ten (13) Agriscience Divisions of the show. Divisions will be classified and divided as follows:

43. Division I - Steer Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Steers will be classified by weight. The steers will be divided into equal or nearly equal-sized classes according to number of entries and weight.
- b. No hair shall be longer than $\frac{1}{4}$ ". Hair shall be allowed on the switch of the tail. Any hair found to be longer than $\frac{1}{4}$ " must be clipped prior to entering the show ring.
- c. No change of the major color pattern of the animal by painting or dying will be allowed. Any exhibitor using grooming material that allows color to come off will disqualify the steer from competition.
- d. Cordless clippers may be used for minor touch-ups.
- e. All steers must be dehorned.
- f. Steers must be healthy at show time or they will not be permitted to show.
- g. Target Market weight is 1000 - 1400lbs.
- h. All steers must be controlled by the exhibitor in the show ring, or they will be removed from the show ring. Dismissal will be determined by the judge and CCISD Agriscience teachers.
- i. All steers will have hair samples pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.

44. Division II- Swine Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. The division will be divided into an equal or nearly equal number of swine per class according to number of entries and weight.
- b. Swine entries may be barrows and/or gilts.
- c. No paints or powders will be permitted.
- d. Cordless clippers may be used for minor touch-ups
- e. Swine must be healthy at show time, or they will not be permitted to show.
- f. Target market weight is 210 - 300 lbs.
- g. Swine will have a hair sample pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.

45. Division III- Lamb Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Lamb entries may be either wether or ewe lambs.
- b. All lambs must be slick shorn.
- c. Cordless clippers may be used for minor touch-ups.
- d. Lambs will be divided into an equal or nearly equal number of lambs per class according to number of entries and weight.
- e. No painting or changing color will be allowed.
- f. Halters or collars on lambs will not be allowed in the show arena.
- g. Unhealthy lambs will not be permitted to show.
- h. Target market weight is 100 - 160 lbs.
- i. All lambs will have a hair sample pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.

46. Division IV- Goat Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Market Goats will be divided into an equal or nearly equal number of goats per class according to number of entries and weight.
 - b. Goats will be handled with a collar, chain or halter.
 - c. All goats must be dehorned or tipped.
 - d. No hair shall be longer than ¼" above the knee and hock joints.
 - e. Cordless clippers may be used for minor touch-ups.
- f. Target market weight is 80 - 110 lbs.
 - g. Goat entries must be wethers.
 - h. Unhealthy goats will not be permitted to show.
 - i. All goats will have a hair sample pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.

47. Division V- Turkey Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Turkeys must be purchased through the CCISD Agriculture Department and must have a wing band present on the turkey at show time.
- b. Each student may purchase between 10 and 15 birds.
- c. Turkey exhibitors are limited to one bird per exhibitor. No substitutes or alternate birds are allowed after the judging begins.
 - d. Once turkeys are checked in, they must remain in the check-in arena until shown. Please provide a box or container to house birds.
- d. Only Hens will be exhibited.
- e. Exhibitors will present only one bird for judging.
- f. Turkey entries must be healthy to show.

- h. Only the Grand and Reserve turkeys will be displayed upon conclusion of judging. The Grand and Reserve exhibitors must provide their own feeder and waterer. Exhibitor is responsible for feeding and watering their turkeys.
- i. All shown turkeys will need to be placed into the assigned pens immediately following the turkey show.
 - j. CCISD Livestock Show & Auction will not floor any non-show birds.
 - k. Students will be responsible for processing and delivery of all poultry sold through the CCISD Livestock Show and Auction.

48. Division VI- Broiler Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Birds must be purchased through the CCISD Agriculture Department and must have a wing band present on the birds at show time.
- b. Each student must purchase a minimum of 25 birds.
- c. Broiler entries are limited to one pen of three birds per exhibitor.
- d. All three birds must be healthy at show time.
- e. Broiler entries can be cockerels or pullets.
- f. Exhibitors will be allowed to present only three birds for judging. No substitutes or alternate birds are allowed after the judging begins.
- g. Once poultry are checked in, they must remain in the check-in arena until shown. Please provide a box or container to house birds.
- h. Only the Grand and Reserve poultry will be displayed upon conclusion of judging. The Grand and Reserve exhibitors must provide their own feeder and waterer.
 - i. All shown poultry will need to be placed into the assigned pens immediately following the poultry show.
- i. CCISD Livestock Show & Auction will not floor any non-show birds.
 - k. Students will be responsible for processing and delivery of all poultry sold through the CCISD Livestock Show and Auction.

49. Division VII - Market Rabbit Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Entry Fee due November 10, 2023. No late the entries will be accepted.
- b. Each student must purchase their own rabbits (cost will vary depending on how much you want to spend). It is the exhibitor's choice to purchase a Buck and Doe(s) to breed a pen of market rabbits, or to purchase a pen of market rabbits. Rabbits will be kept at your home.
- b. The rabbit breed must be Californian.
- c. Suggested breeding dates for the CCISD Livestock Show are between October 1, 2023 and October 8, 2023.
- d. All bunnies must be tattooed by 11:00AM December 20th, 2023 at the exhibitor's home campus. The official CCISD tattoo will be placed in all of the bunnies' right ear.
- e. All rabbits must be healthy and free of ear mites.
- f. Exhibitors may enter only one pen of three (3) rabbits.
- g. Pen of rabbits, three (3), should have a target weight of 15 lbs total.
- h. It is recommended that rabbits be transported in a wire bottom cage.
 - j. Exhibitor will be allowed to present only three rabbits for check-in and judging. No substitutes or alternate rabbits are allowed after check-in begins.
 - k. Only the Grand and Reserve rabbits will be displayed upon conclusion of judging. The Grand and Reserve exhibitors must provide their own feeder and waterer. Exhibitor is responsible for feeding and watering the rabbits.
- i. CCISD Livestock Show & Auction will no longer floor any non-show rabbits
 - m. Students will be responsible for processing and delivery of all rabbits sold through the CCISD Livestock Show and Auction

50. Division VIII - Heifers Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Entry Fee due November 10, 2023. No late the entries will be accepted.
- b. Each division will be divided according to age and number of heifers entered to be determined by CCISD Agriscience teachers.
- c. Heifer Classes will be the following dates:
 - i. Class 1 = Junior Calves; 1/1/23 and after
 - ii. Class 2 = Yearling Calves; 5/1/22 to 12/31/22
 - iii. Class 3 = Senior Heifer; 9/1/21 to 4/30/22
- d. There will be three (3) divisions to include American, British, and Exotics to be shown in the above stated order.
- e. A copy of the registration paper must be submitted with entry form for all American, British, Exotic.
- f. Heifers must be healthy at show time or they will not be permitted to show.
- g. Cordless clippers may be used for minor touch-ups.
 - h. All heifers must be controlled by the exhibitor in the show ring, or they will be removed from the show ring. Dismissal will be determined by the judge and CCISD Agriscience teachers.
- h. One overall Grand and Reserve heifer will be awarded.
- i. Breeding Heifers will not be sold in the auction.
- j. Each breeding heifer will need to be registered/owned in the student's name by November 1st.
- k. Heifers must be born after September 1, 2021.

51. Division XI- Showmanship Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. A showmanship contest will be held for the following divisions:
 - i. Steer
 - ii. Heifer
 - iii. Lamb
 - iv. Goat
 - v. Swine
- b. Each contest will be held immediately following the judging of each division.
- c. Only those animals exhibited in the market show or heifer show and selected by the judge may be exhibited in the showmanship contest by their original owner/exhibitor.
- d. There is no showmanship contest entry fee.
- e. The judge will designate who will be selected and evaluated for showmanship. Exhibitors will be given an item (i.e. token, stamp, etc.) which designates that they have been selected to come back and exhibit in the showmanship division.

52. Division X - Ag Mechanic Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

- a. Entry Fee due November 10, 2023. No late entries will be accepted.
- b. All projects must be owned and built by the dues paying FFA member under the supervision of a CCISD agriculture science instructor who is currently enrolled in the CCISD Agriculture Science program.
- c. A student may only enter one (1) project in each class.
- d. All projects must be clean, painted or treated in a presentable condition even though they may have been used.
- e. Every precaution will be taken to protect the projects entered; however, neither CCISD nor officials of this show will be responsible for loss or damage of exhibit.

- f. A working plan, blueprint or drawing, photographs showing construction, and a bill of materials must be submitted with each project at time of check-in. These must be enclosed in a three-ring notebook.
- g. Divisions: Student(s) must be present during judging.
 - h. Wood
 - Class 1: Individual
 - ii. Metal
 - Class 2: Individual
 - iii. Wood / Metal Combo
 - Class 3: Individual
 - iv. School Project (Not eligible for Auction)
- i. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 17, 2024
- j. **Best of Show and Reserve Best of Show Ag Mechanics Projects must sell in the auction.**

53. Division XI - Floral Design Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

1. No team entries allowed.
2. All arrangements must be designed using either fresh or silk flowers
3. Entries must have been constructed under the supervision of a CCISD agriscience teacher(s).
4. A portfolio/notebook consisting of a design sketch, bill of materials, and pictures of each project's construction steps is required for each exhibitor's entry.
5. Anything judged with the arrangement must be sold with it.
6. No more than one entry per exhibitor.
7. No one will be allowed to interrupt the judge during the judging.
8. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 17, 2024.
9. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds.
10. **Best of Show Floral Design Project must sell in the auction.**

54. Division XII - Visual Arts Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

1. All entries in this division are subject to the general rules and the following Visual Art rules.
2. All entries must have a agriculture related subject focus
3. All visual art projects must be mounted and framed 8x10, unless it is a canvas.
4. No team entries allowed.
5. A portfolio/notebook consisting of a design sketch, bill of materials, and pictures of each project's design progress is required for each exhibitor's entry.
6. There are two (2) classes in this division.
 - Class 1: Photography
 - One black and white print of a person, place, or thing
 - One color print of a person, place or thing
 - OR
 - Class 2: Two Dimensional
 - Oil – work may be on any prepared surface
 - Acrylic, Watercolor – tempra, gouache, casein
 - Pencil, Pastels, Crayon and Charcoal – must be protected with cellophane
 - Ink Drawings – may include colored ink and felt tip drawings
 - Mixed Media – two or more media combined in a single two- dimensional art
7. No more than one entry per class per exhibitor.
8. No one will be allowed to interrupt the judge during the judging.
9. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 17, 2024.
10. Best of Show Visual Arts must sell in the auction.

55. Division XIII - Food Science Rules

This division is subject to all Livestock Show Rules in addition to the following division rules.

1. For judging purposes, two typed copies of a recipe must accompany all food entries on a recipe card attached to the item. The name of the recipe must be on the front of the card with the exhibitor name and school on the back of the card. All food is judged on appearance, color, texture, and flavor of the food only
2. Entries will be displayed on disposable plates and covered with a see-through top (plastic wraps securely fastened, commercial plastic, etc.). Absolutely no containers will be returned.
3. If your food item requires refrigeration, it is the exhibitor's responsibility to make arrangements to keep their food item cool (i.e. displaying entry in a container with ice.)
4. A display of small items such as cookies (Class 1) must contain a minimum of two (2) dozen items.
5. No more than one entry per class per exhibitor.
6. Classes are as follows:
 - Class 1 = Cookies: brownies, bar cookies, drop, rolled, cut out, etc.
 - Class 2 = Cakes: layered, cupcakes, Bundt, etc.
 - Class 3 = Pies: fruit or double crust
7. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 17, 2024
8. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds.
9. No team entries allowed.
10. Best of Show Food Science must sell in the auction, and the exhibitor must furnish a fresh duplicate for the live auction on January 18, 2024.

Steps for Sale Disbursement

to **March 8, 2024**. Your payment will be mailed to the address previously submitted.

1. Under the direction of your respective Agriscience teacher and parent/guardian, you must complete handwritten thank you letters to your buyer, add-on donors, or premium donors, in February of 2024.
2. Your Agriscience teacher will supply you with the name, address, and phone number of your buyers, add-on donors, or premium donors.
3. After writing the letters, your Agriscience teacher must proofread and approve it before it is sealed in an envelope. Your Agriscience teacher will mail these for you.
4. If you sold through the Auction a framed picture will be given to you. You are required to either mail it or deliver it in person along with your thank-you letter.
 - If mailing items, have physical proof of the shipment via mailing receipt or tracking information paperwork saying the item was delivered. If personally delivering items, your buyer must sign to confirm they have received it.
5. If you sold broilers, turkeys or rabbits and they were to be processed and delivered, you are responsible for processing and delivering items along with the thank you letter and picture.
6. Pen assigned at barn cleaned and attended all mandatory "Barn Clean Ups"
7. All fees to FFA Chapter paid in full
8. Turned in Barn Key (s) (\$15.00 penalty fee per key card that is not returned)
9. Additional teacher requirement(s)
10. Please fill out the top portion of the attached Student Completion Form following this page and attach your shipping/tracking documentation or have your buyer personally sign, indicating the buyer received their thank you letter and other necessary items. Leave the bottom portion and amount blank for your teacher to fill in.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)

- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.
